**2. COMPOSITION/INFORMATION ON INGREDIENTS**

Blend of polyolefins, highly-refined mineral oil and additives.  
The highly refined mineral oil contains <3% (w/w) DMSO-extract, according to IP346.

**3. HAZARDS IDENTIFICATION**

<b>Appearance and Odour</b>	: Orange. Liquid. Slight hydrocarbon.
<b>Health Hazards</b>	: Not classified as dangerous for supply or conveyance.
<b>Safety Hazards</b>	: Not classified as flammable but will burn.
<b>Environmental Hazards</b>	: Harmful to aquatic organisms, may cause long-term adverse effects in the aquatic environment.

**7. HANDLING AND STORAGE**

- Exposure Controls** : The level of protection and types of controls necessary will vary depending upon potential exposure conditions.
