Potential Health Effects

- Primary Routes of Entry : Eye contact

Get medical attention if irritation develops and persists.
- Eye contact : In case of eye contact
Rinse thoroughly with plenty of water, also under the eyelids.
If eye irritation persists, consult a specialist.

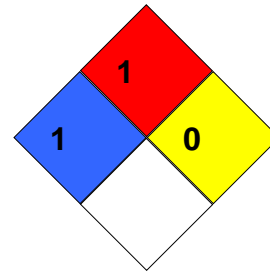
